1. Introduction

- 1.1 Open space provision is always a blend of the consideration of quantity, quality and accessibility, both in terms of existing and potential new facilities. In order to understand the situation in York, the Council commissioned consultants PMP to produce and Open Space Report in 2008 to support the emerging open space policy approach through the LDF Core Strategy. The Report provided a comprehensive audit of open spaces in the City and set locally established open space standards for all typologies of open space compliant with PPG17 as well as a recommended policy approach.
- 1.2 In 2014 consultants AMEC were commissioned to bring the Open Space Study up-to-date and ensure the evidence base was NPPF complaint as this superseded PPG17 as the relevant guidance. Paragraph 73 of NPPF states: "Planning policies should be based on robust and up to date assessments of the needs for open space, sports and recreation facilities and opportunities for new provision. The assessments should identify specific needs and quantitative or qualitative deficits or surpluses of open space, sports and recreational facilities in the local area."
- 1.3 The 2014 Open Space and Green Infrastructure Study therefore considered revisions to the open space audit and the implications these would have on the strategic development sites proposed at that time. The AMEC Study also used the updated information to assess the appropriateness of the current standards of open space provision. The 2014 Open Space Study forms part of the emerging City of York Local Plan evidence base.
- 1.3 Since the AMEC Study was published in September 2014 the Local Government Boundary Commission has implemented an electoral review for the City of York Council. The new arrangements came into force in May 2015 and updated the ward boundaries across the city. It is therefore necessary to update the open space quantums by ward in line with the amended boundaries.

Purpose of this Report

1.4 The purpose of this Open Space Study Update is to reassess the open space quantums based upon the new ward boundaries implemented in 2015 to update the previous data presented in Sections 2.4 and Appendix D of the 2014 Open Space and Green Infrastructure Study. This Open Space Study Update should be read in conjunction with the 2014 Open Space and Green Infrastructure Study as it updates the open space audit data and ward boundaries but retains the overall methodology and agreed typology standards for the different types of open space.

1.5 This report does not update section 3 of the 2014 Study in relation to the application of Open Space Standards to Strategic and Local Development Sites given that final Local Plan including the portfolio of sites is yet to be agreed.

2. Overview of the 2014 Open Space and Green Infrastructure Study

- 2.1 The 2014 'Open Space and Green Infrastructure Study' reviewed the original 2008 Open Space Study and explored the methodology used to ensure it was still fit for purpose. The report also updated the open space supply data and ward profiles as the basis for the checking of the appropriateness of current standards of provision.
- 2.2 An opportunity to assess local provision (by ward/area) in terms of the supply/demand balance and the likely change in context of growth was also undertaken. Furthermore, the report set out policy recommendations for meeting expectations for provision associated with new development and the likely impacts of additional demands on particular localities.

Open Space Standards

- 2.3 Following exploration of the methodology and updates to the supply data, the 2014 Open Space and Green Infrastructure Study concurred that the original Open Space Study (PMP, 2008) established a robust standard of provision across the city for the open space typologies. The original standards therefore remain valid as locally- established benchmarks of provision and are considered to stand comparison with national and comparative benchmarks from other local authorities.
- 2.4 Section 2.3 of the 2014 Open Space and Green Infrastructure Study states: "Analysis of the updated supply data does not significantly alter the baseline, although there has been a notable increase (around 50%) in the provision of children's play space between 2008 and 2013. There is therefore no reason to amend the standards set in 2008 which compare reasonably with national recommendations."
- 2.5 The open space standard typologies and standards are therefore as follows:

Outcomes

- 2.6 Using this methodology, it was concluded that open space provision across the City as a whole was reasonably good (apart from some localised deficits in children's / teenagers playspace). An opportunity was also identified to develop a systematic approach to Green Infrastructure, using the provision of open space within development as a starting point for considering the multifunctional role of open space and the contributions which can be made to City-wide and sub-regional networks.
- 2.7 Further analysis using clusters of wards was also undertaken to reflect more realistic local usage patterns provided the basis for benchmarking the likely implications of strategic development across the City through the mapping of provision and accessibility. Therefore, the 2014 'Local Plan Evidence Base: Open Space and Green Infrastructure' Report grouped the wards into the following 6 geographical areas:

Area	Comprising the following wards:
Urban West	Acomb; Dringhouses; Holgate; Micklegate; Westfield.
Urban East	Heworth; Heworth Without; Hull Road; Osbaldwick.
Central	Clifton; Fishergate; Guildhall.
East/South-East	Derwent; Fulford; Heslington; Wheldrake.
West/South West	Bishopthorpe; Rural West.
North	Haxby; Huntington; Skelton; Strensall.


- 2.8 Using these Ward groupings, the 2014 Open Space and Green Infrastructure Study indicated a surplus / deficit of each typology of open space for each Ward and Geographical Cluster based on the population data.
- 2.9 The outcomes of this work demonstrated that, apart from provision for teenagers and to a lesser extent outdoor sports facilities, there is broadly balanced provision against the 2008 Standards. The deficit in outdoor sports facilities was exacerbated between 2008 and 2013 by the re-classification as amenity open space of sports pitches which do not meet the Sport England quality standard. This had implications for the provision of outdoor sports pitches in particular localities (notably wards in urban east, urban west and central areas) but also across the City where patterns of accessibility of facilities are important considerations.
- 2.10 Furthermore, the pattern of provision reflected the historic development of the City, with urban areas generally having more extremes of provision against the 2008 Standard, such as the Central Area which performs a City-wide role in respect of the provision of parks and gardens, but has limited provision across other types and relies on adjacent areas. There were also clear deficits in some areas which have undergone rapid growth in the past few decades, notably 'Urban East'. Some clusters of wards (of a more rural character) are relatively self-contained in their provision (east/south-east, west/south-west and north) reflecting their settlement pattern, and where certain kinds of provision such as formal parks would not be expected. By contrast, many rural areas hold a significant proportion of the City's natural open space resource.

3. 2015 Ward Boundary Changes and their implications


- 3.1 In May 2015, a number of revisions to the City's Ward boundaries came into force. These revisions were based on the final recommendations of the Local Government Boundary Commission for England, which undertook a review between July 2012 and April 2014. The aim of the review was to improve electoral equality, by ensuring that the number of voters represented by each Councillor is approximately the same. In the City of York, the key reason for the review was that, based on December 2011 electorate figures, the existing Fulford Ward had 33% fewer electors per Councillor than the average for York.
- 3.2 Following consultation on the draft recommendations, the Local Government Boundary Commission supported changes to City of York's ward structure in their final recommendations. The changes suggested City of York having:
 - 5 x single member wards,
 - 6 x two member wards; and
 - 10 x three member wards.

These recommendations ensured that none of the 21 wards would have an electoral imbalance of greater than 10% from average for the City by 2019.

Following the final recommendations of the Local Government Boundary Commission, the revised Ward map for the City of York came into force in May 2015. The following maps compare the ward boundaries, which came into force in 2001 and the new boundaries, which came into force in 2015.







Amendments to Ward based Open Space Provision

- 3.4 Both the 2008 PMP Study and the 2014 Open Space and Green Infrastructure Study based their assumptions on the open space provision by calculating provision per ward against ward population to give surplus / deficit levels for each open space typology against the recommended standard (per 1,000 population). It is now essential that an update is provided to amend the data to match the revised ward boundaries.
- 3.5 Whilst the 2014 Open Space and Green Infrastructure Study anticipated that from 2015 changes to wards may occur (see Appendix G (Table 2.3)), the changes go over and above those changes suggested.
- 3.6 Given the time between the data collection for the 2014 study and this update, revisions to the open space provision and mapping has been undertaken to ensure that any new, revised or lost open space since 2014 has been taken into account. Additionally, where existing boundary clarifications have been identified, these have also been incorporated.

Population values used by ward

- 3.7 The 2014 Open Space and Green Infrastructure Study used the 2011 census as the basis for the ward population figures. In the absence of any more up to date, robust population figures, we continue to use the 2011 Census as a base level for the population figures.
- 3.8 The Office of National Statistics (ONS) has not yet released an update to the data to correspond to the revised ward boundaries. Therefore, officers have undertaken an exercise to rebase the 2011 data into the revised ward areas by combining the Lower Super Output Area data into the different ward boundaries to create a best estimate of the population. Where the Lower Super Output Area boundaries did not fit, a percentage split of the population was used (ie. using a 50% split where the data covered 2 wards) to reach an estimated population. Table 1 sets out the 2015 with their estimated population.

4. Open Space Study Update Outcomes

- Table 2 shows the updated position at 2017 with the revised ward boundaries, population and provision. The table shows the surplus levels (+) or deficit levels (-) in hectares for the ward based on the population figures for that ward and calculated against the set open space standards for each open space typology. Additionally, for comparison purposes Appendix 1 shows the position at 2013 as identified in the 2014 Open Space and Green Infrastructure Study.
- 4.2 Appendix 2 gives a breakdown of the open space provision in each Ward, based on the post May 2015 Ward boundaries. Each ward has a map showing the location of open space and a table listing the open space by typology, together with their calculations for surplus / deficits based on population figures.
