## 11. NIGHT WORK - AT THE DISCRETION OF THE LICENCING AUTHORITY

**Night Work in Broadcasts or Recorded Performances:** The Local Authority may grant a licence for a child to work after permitted hours if they are satisfied that outside scenes, near studios, or on location, is essential and that the child's appearance is necessary.

**Work after midnight:** If work starts after midnight or cannot be completed before midnight, the Local Authority may grant a Licence only:

• If they are satisfied it is impractical to complete work before then

## It is important for the Licence Holder and Chaperones to understand that:

- Hours after midnight count as part of performing time allowed on the previous day, before the child again starts work
- If the child works on two consecutive nights they may not do any more night work for a least another week
- Work may be done in a studio if the weather does not permit outside work.
