Hi all,

We previously discussed the idea of utilising some of the S106 commuted sums for G+T accommodation to employ an officer. The purpose of this role is to project manage the expansion of the Clifton site and to look into opportunities for acquiring other sites and negotiating S106 money from developers where they are not providing traveller pitches on site. The plan is that this officer will sit in the Housing Delivery team as the clear focus is on new pitches. Clearly they will need to work well across services, not just housing.

I am not an expert in this but have put together a first draft of a JD. Could you please have a look and make any track changes if you think something is missing, isn't clear or is just wrong!? Also please let me know if you think others need to comment on this or forward it on yourself. Once we have agreed it I will get approval from Finance to take it through pay and grading.
