## Summary of representations to the Murton Neighbourhood Plan Submission consultation:

Consultation on the Submission version of the Murton Neighbourhood Plan commenced on Wednesday 6<sup>th</sup> November and was scheduled to end on Friday 20<sup>th</sup> December 2024. All documents were made available to viewing on the Council's dedicated Murton Neighbourhood Plan webpage, with a link to it on the Murton Parish Council website. Paper copies of the documents were made available for viewing at the City of York Council's West Offices, York Explore Library and St James's Parish Church, Murton. The documents could also be viewed online at Dunnington Library, Tang Hall Library and the Mobile Library. All residents and businesses within the Parish and properties within a designated buffer zone of the Parish, as well as the statutory consultees, were notified of the consultation by letter or email.

However, following the identification that there were some minor formatting errors in the main document, resulting in some text being partially obscured by text boxes on several policies, the Council contacted the Examiner to make him aware of the issue and on his advice, the document was republished with the corrected formatting and the consultation extended to from Friday 20<sup>th</sup> December 2024 to Friday 10<sup>th</sup> January 2025. Those who had already made representations at the point the issue was detected, were contacted to allow them to amend or provide additional representations if they wished.

The Examination into the Murton Neighbourhood Plan, by Andrew Ashcroft (Independent Examiner) commenced on Monday 13<sup>th</sup> January 2025.

documents I receive from them). The recently revised NPPF may
or may not bring about a future review of housing numbers
identified and the locations for such sites, and it would be for City
of York to address this if they so wish.
The published documents outline the aspirations for the area, with
a focus on maintaining the feel and character of the local area
when considering future development. The Neighbourhood Plan
does not however specifically identify any new housing or
employment related sites, but does identify the need to keep
densities within keeping of the what is existing – nor are scale and
nature of future aspirations quantified. As such any impact from
new employment and housing sites proposed here would be subsumed into the Council's existing calculations and evidence
base (submitted at the last Examination in Public). Should new
developments be forthcoming which would sit outside of the
existing LP settlement plans i.e. new housing, employment, or
retail sites, we would look to review these with York City Council in
the usual manner, with any supporting mitigation they may require
on the Strategic Road Network.
The current consultation shows the wider aspirations of the
neighbourhood plan in a positive light, and this is welcomed. The
proximity of the SRN under my own jurisdiction cuts straight
through the parish boundaries, namely the A64, accessed directly
from the local road network at Grimston Bar. As with all
development within the district boundary, it is expected that the
aggregated impact of all neighbourhood plans will link to the
growing congestion and impacts on the SRN, for which the Council
will need to continue to address in their wider IDP proposals to
ensure a sound local plan infrastructure offering. At this time
therefore, work will continue with the Council to identify any specific

	sites which may have a significant impact to the continued safe operation of the network, and furthermore ensure the Council then continues to ensure financial contributions are collected from developers to provide any necessary mitigation on the SRN.	
The Coal Authority	The area to which this consultation relates is not located within a defined coalfield. On this basis, we have no specific comments to make.	Noted.

CPRENEY welcomes the attention afforded to green infrastructure and the preservation of Green Belt through the document and the valuable points raised regarding effective enforcement. CPRENEY would, however, point out that the published version of the Plan appears to not be formatted correctly with some of the blue policy boxes not showing all text and that some of the boxes overlap with supporting text which will need to be rectified and presumably the formal consultation period amended to ensure full opportunity is given to consider the final documents. City of York Council	We appreciate the amount of hard work and dedication that the Neighbourhood Plan Group and Parish Council has put into this process to produce a locally representative document, detailing the issues which affect Murton Parish. This is particularly appreciated in light of its development in the absence of an adopted Local Plan and the ongoing work on the emerging Local Plan.	
	We consider that the policies in the submitted neighbourhood plan are well written, clear, logical and concise. Our only comment which we wish to submit is that we consider that the Plan should include an overarching Policies Map, which shows all the designations as set out in the Plan – this would consolidate all the maps in Annex 1 to the Submitted Plan. The Council is happy to provide assistance in producing a Policies Map, should the Inspector consider this is required for clarity.
