

NOTICE OF THE MAKING OF A PUBLIC PATH DIVERSION ORDER

PUBLIC FOOTPATH NETHER POPPLETON 1 DIVERSION ORDER 2026

The above order, made on 8 January 2026, under section 119 of the Highways Act 1980 will divert the public footpath from running north of the existing hedgerow (SE 5408 5530 to SE 5444 5531) to the south of the existing hedgerow (SE 5408 5530 to SE 5444 5531) as shown on the order map.

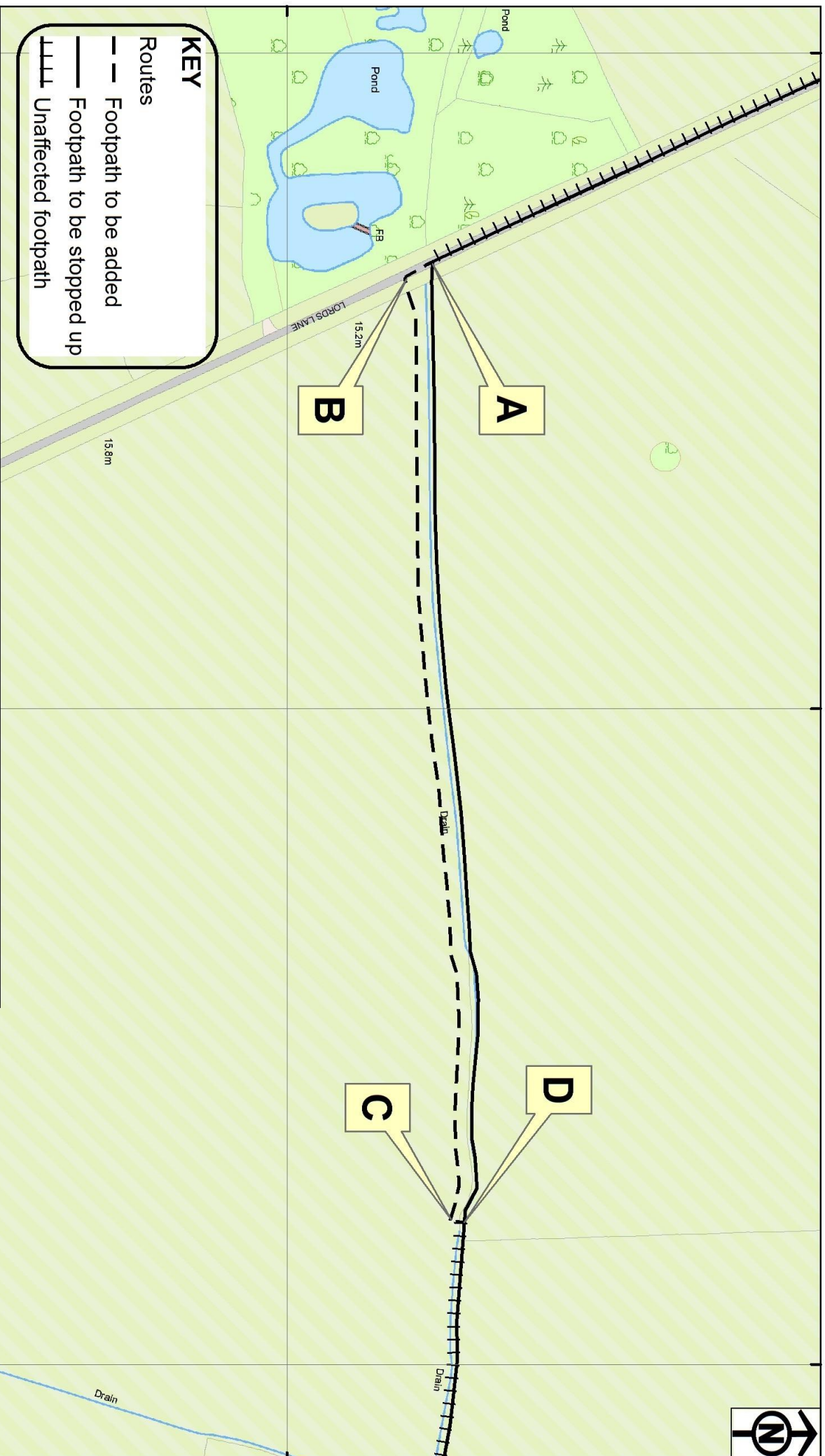
Any representations or objections relating to the order must be sent in writing to “the Rights of Way Officer, City of York Council, West Offices, Station Rise, York, YO1 6GA”, or by emailing rightsofway@york.gov.uk no later than **6 March 2026**. Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Council of the City of York may itself confirm the order as an unopposed order. If the Order is sent to the Secretary of State for confirmation any representations or objections which have not been withdrawn will be sent with the order.

Please note that objections/representations cannot be treated as confidential. Copies of any objections or representations received will be disclosed to interested parties, including the Planning Inspectorate where the case is referred to it for determination.

This Order is made by the Council of the City of York ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

Mr Andrew Frazer, of New Farm, Ouse Moor Lane, Nether Poppleton, York, YO26 6HU and Mr Douglas Frazer, of Willowtree Grange, New Farm, Nether Poppleton, York, YO26 6HU have agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Nether Poppleton Parish Council have been consulted as required by section 120(2) of the 1980 Act;

BY THIS ORDER:

1. The public right of way over the land situate near New Farm, Ouse Moor Lane, Nether Poppleton, York, YO26 6HU and shown by a bold continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up on the date on which the Council of the City of York as highway authority certify that the work has been carried out to bring the site of the new highway, mentioned in paragraph 2 below, into a fit condition for use by the public.
2. There shall, on the date of confirmation of this order, be a public footpath over the land situate at Willowtree Grange, New Farm, Nether Poppleton, York, YO26 6HU described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this order.

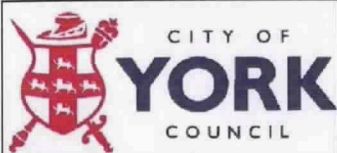
