THE COUNCIL OF THE CITY OF YORK**WILDLIFE AND COUNTRYSIDE ACT 1981****NORTH RIDING OF YORKSHIRE DEFINITIVE MAP AND STATEMENT****PUBLIC FOOTPATHS WESTPIT STRENSALL MODIFICATION ORDER 2022**

This Order is made by the Council of the City of York under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the authority that the North Riding of Yorkshire Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i). This is due to the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic.

The authority has consulted with every local authority whose area includes the land to which the Order relates. The Council of the City of York hereby order that:

- 1 For the purpose of this Order the relevant date is 8 March 2022.
- 2 The North Riding of Yorkshire Definitive Map and Statement shall be modified as described in Part I and Part II of Schedules 1 - 15 and shown on the maps 1 - 15 attached to the Order.
- 3 This Order shall take effect on the date it is confirmed and may be cited as the Public Footpaths Westpit Strensall Modification Order 2022.
