Part 2 - Vehicle Discount and Charges

You can buy a Season Ticket for a minimum of one month.

Discounts are available for low emission, short, electric or LPG powered vehicles. If any of your vehicles fall into the following categories the fee for an annual permit is £600.00, or £80.00 monthly. If you apply for this discount, your permit will become vehicle specific.

- Vehicles less than 2.70 metres in length
- Vehicles in Tax Band A, B or C
- Vehicles that are Electric or LPG powered
- Vehicles that are up to 120g/km

To be entitled to a Low Emissions Permit, you must provide a copy of your Vehicle Registration Document.

If the vehicle you drive is a lease/company vehicle, please also provide a covering letter to substantiate your usage of the vehicle.

If you are unsure which tax band your vehicle is in, you can find out by going to www.vcacarfueldata.org.uk, or by telephoning the City of York Council Customer Centre on 01904 551309. You can also find the emission level of your vehicle at www.gov.uk/get-vehicle-information-from-dvla.
