PAYING YOUR RENT BY DIRECT DEBIT

Did you know that you can now pay your rent by **direct debit**?

Direct debit lets the council request monthly payments from your bank or building society once you have given your permission.

Direct debit is simple and can save you time. The council provides a choice of payment dates – you can choose to pay on the 1st, 8th, 15th or 22nd of the month. You are notified in advance of any changes to the monthly payments the council collects.

Paying your rent by **direct debit** also saves the council money which can be used to make improvements to the housing service it provides tenants.

If you want to pay your rent by **direct debit** please complete the mandate form on the reverse and return it to:
