GATING ORDER FOR A CERTAIN HIGHWAY FOR THE PURPOSES OF
PREVENTING CRIME AND/OR ANTI-SOCIAL BEHAVIOUR

THE COUNCIL OF THE CITY OF YORK

SCARCROFT HILL WENTWORTH ROAD GATING ORDER 2007

This Order is made by the Council of the City of York, under the Highways Act 1980, Section 129A ("the Act") as highway authority for the highway indicated below because it appears that:-

- (a) the requirements of Section 129A(3) in respect of the said highway are satisfied; and
- (b) that it is expedient for the purposes of preventing or reducing crime and/or anti-social behaviour that public pedestrian use of the said highway be restricted as this Order provides.

BY THIS ORDER

- 1. The public pedestrian use of the highway indicated in paragraph I of the Schedule below should be restricted;
- 2. That such restriction should apply at all times;
- 3. That such restriction shall not apply to those parties whose interests would otherwise be affected by this Order and whose interests are identified as those protected by Section 129B (3), (4) and (5) of the said Act as amended; and
- 4. That the alternative route is as indicated in paragraph II of the Schedule below.

THE SCHEDULE

- I. The route to be restricted commences from the side of No51 Scarcroft Hill at Grid Reference SE 5954 5078 (Point A on the map), continuing in an easterly direction for 48 metres to the rear of No9 Telford Terrace at Grid Reference SE 5958 5077 (Point D on the map); also from the rear of No6 Telford Terrace at Grid Reference SE 5957 5078 (between Points A & D on the map) continuing in a north easterly direction for 82 metres to the rear of No2 Wentworth Road at Grid Reference SE 5959 5085 (Point B on the map); also from the rear of No29 Scarcroft Hill at Grid Reference SE 5959 5083 (between Points A-D and B on the map) continuing in an easterly direction for 15 metres to between the sides of No8 & No10 Wentworth Road at Grid Ref SE 59609 5083 (Point C on the map), as shown by a bold continuous line on the Order map.
- II. The alternative routes which will be available to pedestrian traffic if the Order is made, are the footways which make up part of the highways known as Scarcroft Hill, Wentworth Road and Telford Terrace.

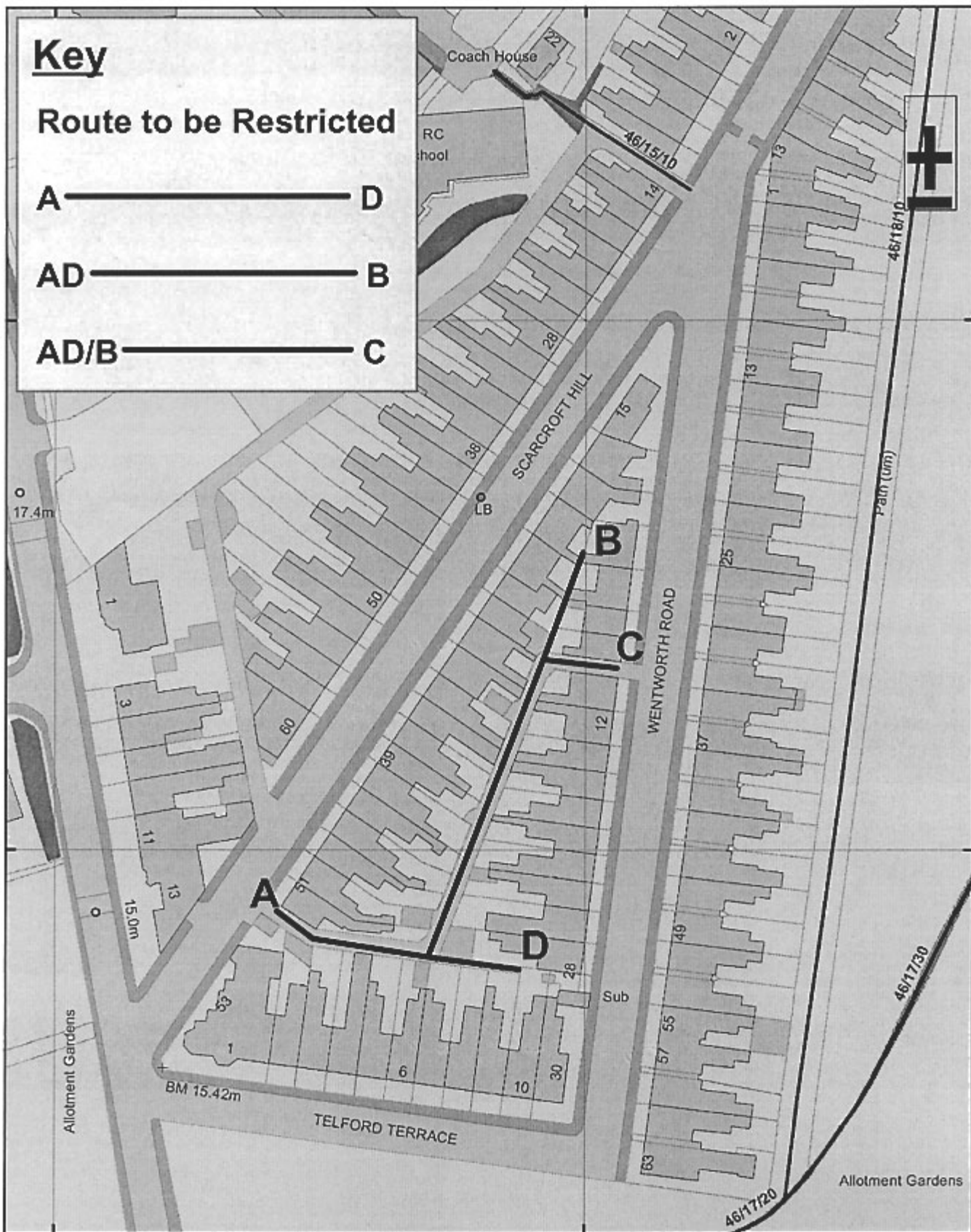
