## CYC Local Plan Examination Key Infrastructure Requirements – Updated Gantt Chart, January 2022

- 1. The National Planning Policy Framework, 2012 (the version of the NPPF City of York's Local Plan is being examined under) states Local Plans should plan positively for the development and infrastructure. It requires local planning authorities to, amongst other things, set out strategic policies to deliver:
  - Infrastructure for transport, telecommunications, waste management, water supply, wastewater, flood risk and coastal change management, and the provision of minerals and energy (including heat); and
  - Health, security, community and cultural infrastructure and other local facilities.
- 2. NPPF 2012 (paragraph 162) requires local planning authorities to work with other authorities and providers to assess the quality and capacity of this infrastructure to meet forecast demand. It goes on to state that is important to ensure "that there is a reasonable prospect that planned infrastructure is deliverable in a timely fashion. To facilitate this, it is important that local planning authorities understand district-wide development costs at the time Local Plans are drawn up" (paragraph 177).
- 3. An <u>Infrastructure Plan May 2018 (SD128)</u> was submitted alongside the submission version Local Plan in May 2018. This was to address national policy requirements outlined above and is intended to support the implementation of York's Local Plan.
- 4. Updates to this document in the form of a Gantt Chart were subsequently published in response to a request from the Inspector in November 2018:
  - <u>EX/CYC/7b Addendum to Annex 4 of IDP, 14 November 2018</u> (Gantt Chart) Previously Submitted
  - EX/CYC/7c Errata addendum to IDP, 14 November 2018
- 5. In October 2021 the Local Plan Inspectors asked CYC to "produce an up-to-date Gantt Chart of all site allocations in the Plan showing their anticipated delivery of housing development year by year of the plan period (and beyond). In addition, on the same Gantt Chart, the required infrastructure (particularly relating to education and transport) to support development requirements and their anticipated delivery timescales year by year of the plan period (and beyond) are also to be plotted. This should be laid out in such a way as to make a clear comparison between anticipated delivery of housing and employment development and the provision of the necessary infrastructure to support that growth.
- 6. This note provides an updated Gantt chart of **key** infrastructure requirements associated and anticipated timescales for delivery to growth anticipated in the Local Plan. To aid legibility the format has been amended to present infrastructure requirements by type which are presented alongside the site allocations (rather than by 'spatial level of infrastructure' show in the November 2018 update).
- 7. This update has been focussed primarily on education and transport infrastructure. In relation to education, it takes into account latest demand estimates (and the capacity of existing education facilities). The approach to demand estimates arising from strategic sites with delivery beyond the Local Plan period (2017-2033) has been to acknowledge the uncertainty surrounding educational requirements due to trends that will change such as birth rates. In relation to transport it provides an update on new transport commitments. Further sensitivity testing is ongoing in relation to modelling impacts associated with implementation of these and while this not likely to alter the proposed spatial approach, results can be made available ahead of the next stage of hearings. With reference to ST15 Land West of Elvington Lane specifically, this site has a Garden Village status and infrastructure requirements, and

funding sources will be considered in partnership with Homes England to unlock the development potential of this site.

8. A more comprehensive update of the IDP is underway with the intention of establishing a more regular cycle of updates to support the Local Plan implementation. It is also the case with the intention for the IDP to be a 'working document' that these regular updates of the IDP will allow for a nuanced approach to delivery in light of updates, changing trends and new delivery mechanisms.

The following schedules print at A3, but are intended to be viewed electronically as with the 2018 Gantt Chart previously published.

**Note:** This document was corrected in March 2022 to correctly attribute a secured primary school contribution to ST1 (and not ST14) on page 3 and to delete reference to committed sum against secondary schools on the first row on page 4. This was a drafting error, rather than an error in the source data, and changes do not impact on the Plan content or associated Local Plan viability testing.
