When respondents answering the following questions identify a deficiency in the Local Plan, they should make clear how it should be changed.

In accordance with the Transitional Arrangements set out at paragraph 220 in Annex 1 of the National Planning Policy Framework 2021, where a plan is being examined that was submitted on or before 24 January 2019, the policies in the previous 2012 version of the Framework will continue to apply, as will any previous guidance which has been superseded. Accordingly, the Local Plan is being examined against the 2012 version of the National Planning Policy Framework. As such, all further references in this document to the 'National Planning Policy Framework' or 'the Framework' are to that 2012 version.

#### Matter 1 - Green Belt Boundaries

- 1.1 Are the inner Green Belt boundaries (Topic Paper 1 Addendum Annex 3 Sections 1-4) reasonably derived?
- 1.2 Are the inner Green Belt boundaries (Topic Paper 1 Addendum Annex 3 Sections 5-7) reasonably derived?
- 1.3 Are the Green Belt boundaries of 'Other Densely Developed Areas' (Topic Paper 1 Addendum Annex 4) reasonably derived?
- 1.4 Are the outer Green Belt boundaries (Topic Paper 1 Addendum Annex 2) reasonably derived?

## Matter 2 – University of York

- 2.1 What are the needs of the University of York?
- 2.2 How many jobs are projected to be created by the University of York in the Plan period?
- 2.3 Will that level of job creation have any consequent impact on the Plan's OAN for housing?
- 2.4 Does the Plan properly provide for the needs of the University?
- 2.5 Are Policies ED1-ED3 effective as an approach to the University of York?
- 2.6 Is the 23% restriction on the developed footprint in Policy ED3 justified?
- 2.7 Is Policy SS22 (ST27) soundly based?

- 2.9 Is the 23% restriction on developed footprint in Policy SS2 justified?
- 2.10 Is the approach of the Plan to the University of York justified in Green Belt terms (whether in terms of Green Belt boundaries, or 'washing over')?

- 4.5 Is the manner that listed buildings and their settings are treated in Policy D5 sound?
- 4.6 Does Policy D6 deal with archaeology in a way that offers sufficient protection?
- 4.7 Is the approach of Policy D7 to non-designated heritage assets reasonable in the light of national policy?
- 4.8 Are Historic Parks and Gardens properly dealt with by Policy D8?
- 4.9 What is the basis for Policy D9?
- 4.10 Will Policy D10 offer appropriate protection for the City Walls and St Mary's Abbey Walls (York Walls) and their settings?
- 4.11 Is the approach to the alteration and/or extension of existing buildings in Policy D11 soundly based?

- 4.12 Will Policy D12 effectively protect existing shop-fronts and secure acceptable new one?
- 4.13 Is Policy D13 an acceptable approach to advertisements?
- 4.14 Is Policy D14 an acceptable approach to security shutters?

#### Matter 5 – Green Infrastructure

- 5.1 Is the general approach of Policy GI1 to green infrastructure sound?
- 5.2 Does Policy GI2 deal with biodiversity and access to nature in a reasonable way?
- 5.3 Will (new) Policy GI2A and the associated text be effective in protecting Strensall Common SAC?
