In February, the Centre for Cities report found York to be the least affordable city in the north of England, ranked at 13th nationally (the next northern city was Manchester ranked 32nd nationally). As per the YLP submission, 2021 census data confirms working age families are being displaced. I reiterate YLP's request that the Inspector recommends the Council commissions additional work around the housing numbers.

It is important to keep land permanently open to preserve the setting of the historic city, to prevent urban sprawl and to safeguard the countryside from encroachment. I, therefore, request that the boundary line of the green belt, follows the edge of the St. Peter's school building, as per the 2021 modifications; PM75 within EX/CYC/58: Composite Modifications Schedule April 2021.

I am concerned that shifting the previously proposed greenbelt boundary and giving this land an 'education allocation' will pose a risk to the openness of the land, with its clear views of the Minster within a compact urban setting. The fields of St Peter's and Queen Anne's play a vital role in off-setting the density of the urban setting and provides a vital public amenity —as a green, open space forming part of the river corridor. As part of this river corridor, the land functions as part of the 'countryside' offering openness and views.

The green wedge and wider biodiversity connection to the Site of Special Scientific Interest at Rawcliffe Meadows and Clifton Ings is important environmentally as well as being of high amenity value within the inner green belt area. Further to this, I am concerned that views of the Minster could be impacted by opening up the increased risk of unrestricted sprawl e.g. if the new designation allowed for the introduction of floodlit, artificially-surfaced hockey pitches on this land. The previously proposed line (PM75 EX/CYC/58 [2021]) offers a more robust boundary to the Green Belt at St Peters School with a greater degree of permanence.
