Morning Kirstin

We might be pushing it to accommodate 10 but I think it might be possible if we reconfigured at least part of the site and there is a lot of bunding surrounding the site which we may be able to remove. It would be a very good time to upgrade/rebuild some of the current wash houses on that site which are very old (nearly 50 years) if we could do that at the same time (a big ask I know). It would need to be done in parts so that we can move people once some new pitches are built so that we can rebuild/ upgrade others.

I think 5 years to do all of that is a challenge but clearly this is something we will have to do.

The government current guidelines around size of sites is for 12 to 15 pitches and Clifton already has 23 pitches so we would need I think to split the site as that would total 33 pitches and to be honest would make it very difficult to manage.

We may need to look at how we manage the sites too within this increase of pitches.

• Our plan says we will provide another 3 pitches on our existing sites. **If** we need 5 pitches rather than 3 on existing sites can we fit 2 more pitches on any of the sites or split across the sites?

Yes we can. For example, on the site in Clifton we have over 2500 sq m of land which is undeveloped. With some re-configuration of some of the existing pitches we could physically accommodate five additional pitches on the site.

• This could be done either via increased densification or an extension to the sites.

As above it would be increased densification, we wouldn't need to purchase additional land or extend the boundaries of the site.

• Would the site license allow us to do this?

This is where I am not an expert and colleagues in that part of housing are on leave today but could hopefully confirm first thing on Monday morning. There is guidance on how many pitches should be on each site. If we were to exceed this there has been some conversation about the potential of splitting the existing Clifton site into two with their own access points, open space, and facilities. Physically we believe this could be accommodated on site.

In respect of your query about S106 money. We have written a job description for a Gypsy and Traveller Accommodation Officer. This is going through the usual HR processes so that the post can be added to the establishment. The role will sit within the Housing Delivery Programme team to benefit from the development expertise that sits within that team. The role will be funded from S106 monies. The role will project manage the delivery of additional pitches on existing sites, liaise with developers regarding delivery on strategic housing sites, and bring forward other development options to meet the need identified in the local plan. This will include land identification, stakeholder engagement, design and planning process, procurement and delivery on site. We anticipate having someone in this role before the end of the year.
